Questions addressed: The title of the conferences / meetings provide basic information on the topics discussed. Conferences have mainly focused on regional territorial developments and problems, in particular on borders, multi-cultural regions and the changing nation-state principles. Political geographers came to conclusion that the "...the Westphalian territorial ideals have made the territorial state the privileged unit for analyzing most phenomena ..." (Murphy, 1996) - while discouraging other views in regard to territorial identity of people, their interplay and organization. Political geographers have identified virtual territorial sovereignties in the form of Internet, monetary

flows and multifaceted aspects of globalization and have identified them under the term "mobile/shifting borders". The migratory intensity of people in the contemporary world changes to large extent the traditional culture, nation, and nation-state territorial acceptance. The environmental sphere was accepted to the field and we've agreed to the concept of trans-state and cross-border discussion of the issue within political geography.

- **3. Networking:** The Commission on Political Geography cooperated successfully in preparing a session ("Borders in the Mediterranean") with the Mediterranean Renaissance Project (MRP) at the International Geographical Union at the IGU Regional Conference in Tel Aviv, Israel. The commission was supportive of the activities of the MRP since its rejuvenation at the IGU Geographical Congress in Tunis, Tunisia in 2008. Members of the Steering Committee and the members are active participants in the works and meetings of IPSA Political and Cultural Geography of the International Political Science Association, in particular within the Research Committee 15 (Political Geography. Cooperation was intensive in organizing meetings with the local national committees and is steady with geographic associations (AAG, BRIT, DGG, IBRU, ...) and their bodies working on the subject of political geography (sub-associations, institutes and specialty groups).
- **4. Publications:** Due to its overwhelming quantity, it is impossible to cite all books printed in authorship of members of the Commission. - **6. Continuation** The IGU Commission on Political Geography can demonstrate with confidence the successes it has achieved in relation to the mandate 2008 2012. In period of the most recent mandate, the Commission organized 26 meetings (four more than in the mandate of the commission 2004 2008) and printed 18 proceedings (five more than in 2004 2008). Commission's members published close to 45 books on several topics within the 7 main subjects of the sub-profession: on disputes over territory, e.g. border disputes; on relationship between cultures and politics; on sociodemographic structures and migratory patterns; on the global economic interplay; on the geography

of political representation; on world's post-modern developments and threats; and within the wide array of critical geopolitics. The rapidly changing political frame of the world, the human impacts on environment and intercultural relations will be the main frame of future works of members of the commission. (Future) Name: Commission on Political Geography; Statement: The objectives of the Commission for next four years will be to continue the study of main theoretical issues of political geography as a fundamental geographical discipline (scale, place, post-modernity, etc.) and the relationships between the new geopolitical world order and other formal and informal levels of the political-territorial organization of society - including: post-modern geopolitics and political geography, the main notions and methods, common and particular trends, research methods in political geography, the dynamic of the relationships in the triade "identity – territory - boundaries" under the influence of globalization, new tendencies in nation building and the crisis of the Westphalian system, networking and the appearance of new global actors, cross-border cooperation as a condition of sustainable development (environmental, economic, social, cultural and political), re-visit to electoral geography, advancing on research of regional political geography (large urban agglomerations and world cities, coastal areas, regions of ethnic tensions and of international crisis, etc.), and initial studies on climatic changes and its impacts in the sphere of political geography. New Steering Committee: In place are also nominations for members of the Steering Committee who should replace members who have served in Commission's Steering Committees for two mandates (8 years). Contemporary Political Geography – The View. The acting Chair of the IGU Commission on Political Geography has in 2010 started an initiative to set up a monograph on contemporary political geography as perceived by 1.) not acting presidents of the Commission 2.) by acting lead-editors of journals in political geography/geopolitics; 3.) by authors of contemporary textbooks on political geography. Chair's initiative failed as from former CPG chairs just two (Sanguin, van der Wusten) have responded positively. The acting IGU vice-president encouraged the IGU CPG Chair to renew the initiative. It is not certain that the idea would enable the promotion of political geography at the IGU main conference in Cologne (2012), but even on a later date such an in-depth overview of the profession should be welcomed.

The conference will provide a forum for exchange for political geographers prior to the IGC 2012 meeting in Cologne with the goal of moving forward current conceptual, methodological and empirical research agendas in Political Geography and Critical Geopolitics. We encourage the submission of abstracts (max. 300 words) for paper presentation, organized sessions and round-table discussions. To ensure high academic standards at the conference, submitted abstracts will be reviewed by an international committee before acceptance. Discussion will form around two major topics: A: Integration and Disintegration of the Nation State. The role of the nation state and the territorial order of the world's political map have significantly changed over the past two decades. In the face of ongoing economic globalisation the geopolitical influences of transnational corporations and networks of financial speculation have become ever more palpable. In the political realm, networked players such as terrorist networks, regional warlords and new social movements are growing in importance. Simultaneously, ongoing inter-state conflicts, debates on homeland security, the biopolitics of citizenship, hardening borders and reinvigorated state institutions in the face of financial and fiscal crisis in the EU and the US show that the nation state is far from disintegrating into a space of flows. The conference seeks to invite contributions that discuss these challenging developments from different theoretical perspectives as well as through different case studies. B: Critical Geopolitics 2012. Four years after the Critical Geopolitics 2008 conference at Durham University, we seek to invite contributions addressing the state of Critical Geopolitics and its evolution as an interdisciplinary research approach across the social sciences. Particular attention shall be paid to Critical Geopolitics' interdisciplinarity in both conceptual and methodological terms as means of exploring inter-dependencies between the global and the local. Fukuoka, Japan & Busan, Korea: November 13 – 16, 2012. BRIT XII – BORDER REGIONS IN TRANSITION: BORDERLAND VOICES - SHAPING A NEW WORLD ORDER. Against the

background of the current "border studies renaissance" fashioned in North/South America, Europe, the Middle East and Africa; Eurasia and East Asia have long been a vacuum in the "international" border studies community. Hokkaido University's Slavic Research Center, regarded as one of the most active institutions on Eurasian area studies in the world, has decided to invite established but fragmented individual researchers working on Eurasia and East Asia border-related topics to create a research network for border studies. We have also organized a united forum and developed collective works in the theory-conscious framework of border studies and have coordinated the establishment of Japan International Border Studies Network (JIBSN) with local/central administrative practitioners. Border studies itself has yet to fully mature and needs a solid foundation to integrate fragmented regional facts. The urgent task at hand is to find and identify a theoretical tool so as to compare various approaches and expertise throughout the regions. Without this process, border studies, though endowed with rich and suggestive materials, will not be able to make a fruitful contribution as an interdisciplinary and multi-vectored field of research. In order to engage more people in this new network and to advance it into a worldwide one, we are now preparing for a borderland symposium that will take place in November 2012 under the auspices of the prestigious Border Regions in Transition (BRIT). Day one and day two of the symposium will be held in the city of Fukuoka, Japan, followed by a field trip to Tsushima, a border island, on day three. On day four the symposium will conclude in Busan, Korea. The city of Fukuoka and Kyushu University have pledged their full support. Also, November is an ideal month for viewing sumo, Japanese traditional wrestling, in the city. Dongseo University in Busan is pleased to host the last part of this symposium. With local support, our program will be realized an epoch-making event, especially in cooperation with distinguished Eurasian border researchers and with institutions from Central Asia, South Asia, Southeast Asia, China and Russia. With the cooperation of the border cities of Fukuoka and Busan, the first East Asian BRIT will truly be a historic event.

The BRIT XII (Fukuoka-Busan 2012) Organizing Committee invites all academic researchers and practitioners working on borderlands policy and border studies to participate in the BRIT XII Conference, a multi-disciplinary/area studies scientific meeting dedicated to the study of borders in all parts of the world. The conference will take place in Fukuoka, Japan and Busan, Korea, November 13-16, 2012. These locations provide an ideal setting for further understanding the realities of cooperation and conflict over Northeast Asia's maritime and land borders. The conference will include an opportunity to participate in a special tour of beautiful Tsushima Island which lies halfway between Fukuoka and Busan. While papers on all topics and geographical areas related to border studies are welcome, the theme of BRIT XII is Borderland Voices: Shaping a New World Order. Papers addressing this theme will examine how those living in borderlands have been affected by the "bordering" processes of the state and central authority; how the voices of borderland communities can challenge the prevailing nation-state order; and the strategies and initiatives that people in the borderlands have devised in order to seize opportunities and overcome the difficulties associated with life on the border. Views from the borderlands give us fresh insights into the dynamic relationship between state and society; center and periphery; security and insecurity; politics and identity; territory and belonging. The theme of BRIT XII comes as a timely reminder that it is border communities (often marginalized, overlooked and powerless) who are most sharply affected by the global shifts represented by the terms "debordering" and "re-bordering." However, these communities are not passive actors but part of a two-way process where those living in the borderlands are forming new kinds of connections and spaces. For borderland communities the power, violence and connectivity of the border are part of the very fabric of daily life. The border really matters to those living on it and border studies can uniquely engage with those metaphorically and geographically on the margins. It is a scholarly endeavor that has a humanitarian significance beyond the boundaries of academia. BRIT XII offers opportunities to use multiple lenses (from local to global) as well as cross-disciplinary approaches to refocus on the border in new and innovative ways. As part of this innovation, BRIT XII seeks to promote the development and advancement of theoretical and methodological approaches to border studies. Therefore, panels on theory and methods will be particularly welcome. Among other topics, we are also interested in accepting papers and panels on the following:

KYOTO, JAPAN; August 4 – 9, 2013. IGU REGIONAL CONFERENCE: TRADITIONAL WISDOM AND MODERN KNOWLEDGE FOR THE EARTH'S FUTURE

The National Committee of Japan and The Science Council of Japan are organizing the next Regional Conference of the International Geographical Union in Kyoto, Japan (August 4 – 9, of Conference 2013) within premises the Kyoto International Center (http://wwwsoc.nii.ac.jp/hgeog/igu2013/igu2013.html). The major direction conference will be related to the heavy environmental burden humans have imposed on Earth. According to the title of the conference we should return to traditional wisdom and implement modern knowledge for the Earth's future. CPG IGU Steering Committee member Takashi Yamazaki (yamataka@lit.osaka-cu.ac.jp) is also a member of the Organizing Committee and will act on our behalf. We are planning to arrange a pre/post conference in accordance to directions of the Kyoto organizing committee.

III - Past Events

TEL AVIV, ISRAEL: "Bridging Diversity in a Globalizing World". At the Tel Aviv, Israel IGU Regional Meeting conference "Bridging Diversity in a Globalizing World" (July, 2010) the CPG (C30) organized 4 sessions and 16. Our Steering Committee member Dr. David Newman organized a well attended pre-conference "Border, Territory and Conflict in a Globalizing World" (close to 70 participants and 21 presentations) at the Ben Gurion University in Beer Sheva. The guided excursion from Beer Sheva to Tel Aviv, through Palestinian Territories and two tough Israeli control posts, was an enlightment for the international group of political geographers.

SAPPORO, JAPAN: "Reshaping Japan's Border Studies". The Slavic Research Center of the Hokkaido University in Sapporo, Japan and its dynamic director Akihiro Iwashita, invited selected members of the CPG Steering Committee to participate at the International symposium "Reshaping Japan's Border Studies" (December 3 - 5, 2010). Some aspects of the symposium were later (Dec. 6, 2010) presented at the Sasakawa Peace Foundation in Tokyo.

GENEVA, SWITZERLAND - GRENOBLE, FRANCE: BRIT XI - Border Regions in Transition XI: Mobile Borders. The XIth conference of the BRIT (Border Regions In Transition) network was held in Geneva and in Grenoble from 6 to 9 September 2011. This major event, organized every two years on a different continent, on both sides of a border, took place for the first time in France and in Switzerland. It was attended by more than 280 participants, including researchers, professionals and students. The BRIT is an international and interdisciplinary scientific network which regularly holds meetings attended by the world's leading specialists on border and geopolitical issues, with the particular feature of gathering analysts and practitioners around a border which they cross together, a condition for very fruitful debates. The aim of this conference, co-chaired by Anne Laure Amilhat Szary (Joseph Fourier University- PACTE/Institut Universitaire de France) and Frédéric Giraut (Geneva University), was to assess the concept of "mobile borders", a provocative expression questioning the status of these spaces which globalization has transformed. Borders are no longer linear and the control functions attributed to these arbitrary lines are now often dissociated from the physical boundary between the two countries. When border functions diffuse far from the boundary line, one can question the remaining meaning of the conventional line, and when displaced elsewhere, can these still be qualified as border functions?

In addition to the plenary addresses, more than 180 communications, grouped in some forty sessions, were programmed for the attendees. This year, Africa was in the place of honour, and Michel Foucher, expert with the African Union together with the South-African scholar *Maano Ramuntsindela*, concluded the conference which guest of honour was Mrs. Saskia Sassen, sociology professor at Columbia University, USA. The convenors were also pleased to discover the presentation-performance given by the artist Ariane Littman (*www.ariane-littman.com/*) and very interested in the conference given by Olivier Clochard, president of the Migreurop NGO network. The scientific results of the conference are wide-ranging. It was an opportunity to analyze the many meanings of the concept of "borders" by showing that borders undergo constant processes of opening ("debordering") and closing ("rebordering"), which make them very diverse in their forms and in their manifestations. Their spatial inscription, increasingly difficult to define, produces more fluid, open or fuzzy borders.

Beyond the renewal of knowledge on the state of world borders, the BRIT attendees have various explored post-modern modalities of contemporary "rebordering", thus evidencing: 1. the selectivity of borders themselves, as that their functions; 2. the emergence of new borders, created by private or public agencies; 3. the importance of boarded borders, with the existence or non-existence of rights attributed to migrants who become holders of franchises or exclusions; 4. the growing weight of control and subjection technologies.

ZADAR, CROATIA: The Adriatic Forum IV "Geopolitical Issues of the Adriatic – Yesterday, Today, Tomorrow". The Adriatic Forum IV "Geopolitical Issues of the Adriatic – Yesterday,

Today, Tomorrow" was organized by the University of Zadar (September 16-18, 2011). As much as 41 participants from 16 countries participated actively at this event and 32 papers were presented. The main conclusion was that the Adriatic region is continuously undergoing different political, social and economic changes, so the role of the geographers is to analyze and discuss those changes and present the research results, of course, in cooperation with scientists from other, related, scientific disciplines. The last day of the conference included a bus excursion to Zadar hinterland and Pag Island.

KIEV – **CRIMEA, UKRAINE:** "Territorial Identity in the Contemporary World". The Department of Geography at the Ukranian Academy of Sciences organized the CPG IGU's central annual conference on "Territorial Identity in the Contemporary World" in Ukraine (Kiev and Crimea, September 18 – 23, 2011). Interesting discussion evolved around the Westphalian principles in the contemporary changing world of nation-states (and other type of states).

PORTOROŽ-PORTOROSE, SLOVENIA: "(Re)Integration and Development Issues in Multicultural and Border Regions". The Institute for Geographical Studies and the Institute for Mediterranean Humanities and Social Studies of the Science and Research Centre of the University of Primorska (Koper/Capodistria, Slovenia) have organized the international conference on "(Re)Integration and Development Issues in Multicultural and Border Regions" in Portorož/Portorose, Slovenia (September 22 - 24, 2011). The aim of the Conference was to give an assessment of past developments and conflict resolutions, an analysis of current situations and problems concerning spatial and social cross-border and inter-cultural integration/disintegration, and an evaluation of the future trends and opportunities for cooperation and development within a broader European and global context.

PECS, HUNGARY: "Integration and Geopolitics in the Balkans and in the Mediterranean". The Department of Political Geography and the Regional Development Institute at the University of Pécs, Hungary has organized an international conference on the topic of "Integration and Geopolitics in the Balkans and in the Mediterranean" (October 26 – 28, 2011). The conference proceedings will be published and selected papers published in a Hungarian journal "Mediterrán Világ".

SANTIAGO, CHILE: *UGI 2011 International Geographical Regional Conference*. The IGU Regional Conference has been organized at the Escuola Militar in Santiago de Chile from November 14 - 18, 2011. Prof. Andre-Louis Sanguin acted as coordinator of our CPG IGU commission. The CPG IGU has not organized any pre- or post-conferences, but has traditionally organized the Steering Committee members' discussion and has participated at chair meetings. IGU provided travel grants for those interested in attending the conference.
